

Do Not Call Register

Application to register numbers

What is the Do Not Call Register?

The Do Not Call Register is a secure database where you can register your Australian numbers to opt out of receiving most unsolicited telemarketing calls or marketing faxes. Registration is free and you only need to do it once.

What numbers can be registered on the Do Not Call Register?

- > Numbers that are used or maintained primarily for private or domestic purposes. Individual account holders or nominees acting on behalf of other individual account holders can register these numbers.
- > Numbers that are used or maintained exclusively for use by a government body. Authorised officers of government bodies can register these numbers.
- > Numbers that are used or maintained exclusively for transmitting and/or receiving faxes. Authorised officers of businesses can register these numbers.

How to use this form to register numbers

1. Complete all the sections below (A to D) and provide signatures where required.
2. Attach/provide a copy of the front page of a bill or other supporting evidence to verify the account holder for each number.
